AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF  
TAXES FOR THE VILLAGE OF CHANNAHON, WILL AND

BEGINNING MAY 1, 2009 AND ENDING APRIL 30, 2010

BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF CHANNAHON, WILL AND GRUNDY COUNTY, ILLINOIS AS FOLLOWS:

SECTION 1: That the sum of One Million Nine Hundred Twenty Three Thousand Five Hundred Forty Two and no/100 (\$1,923,542.00) dollars be and same is hereby levied and assessed upon and against all real and personal property within the corporate limits of the Village of Channahon, Counties of Grundy and Will, State of Illinois, which is subject to taxation according to the valuation of said property as the same is assessed and equalized for State and County purposes for the fiscal year beginning May 1, 2009, and ending April 30, 2010 of said Village of Channahon which sum is to be applied in payment and satisfaction of the appropriations heretofore made by said Village of Channahon in Ordinance No.1578 passed on the 6th day of April, 2009, A.D., by the Board of Trustees of the Village of Channahon, Will and Grundy County, Illinois, for all corporate purposes of said Village, for said fiscal year.

SECTION 2: That the said sum of One Million Nine Hundred Twenty Three Thousand Five Hundred Forty Two and no/100 (\$1,923,542.00) dollars is levied and assessed for the following items which appropriations have been made; that the total amount appropriated is set forth under the column designated "Total Appropriation"; that the total amount to be hereby levied to be raised by taxation is set forth and described under the column designated "To Be Raised By Tax Levy"; and that part or portion thereof to be raised from sources other than taxation is set and described under the column designated "Estimated Receipts From Other Sources", all as set forth on Exhibit A attached hereto and made a part hereof.


SECTION 3: That the total amount of One Million Nine Hundred Twenty Three Thousand Five Hundred Forty Two and no/100 (\$1,923,542.00) dollars ascertained as aforesaid be, and the same is hereby levied and assessed on all property subject to taxation within the Village of Channahon according to the value of said property as the same assessed and equalized for State and County purposes for the current year.

SECTION 4: That there is hereby certified to the County Clerks of Will and Grundy County, Illinois, the several sums aforesaid, constituting the said total amount of One Million Nine Hundred Twenty Three Thousand Five Hundred Forty Two and no/100 (\$1,923,542.00) dollars, which said total amount the said Village of Channahon requires to be raised by taxation for the current fiscal year of said Village, and the Village Clerk is hereby ordered and directed to file with the County Clerk of said Counties on or before the time required by law a certified copy of this Ordinance.


SECTION 5: That all ordinances, or parts of ordinances, conflicting with any provision of this ordinance be and same are repealed.

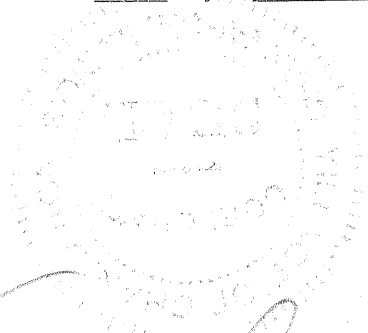
SECTION 6: This ordinance shall take effect and be in full force and effect immediately on and after its passage, approval, and publication in pamphlet form as provided by law.


