ORDINANCE NO. 1609

AN ORDINANCE AMENDING THE VILLAGE OF CHANNAHON CODE OF ORDINANCES WITH RESPECT TO IMPOUNDING MOTOR VEHICLES

WHEREAS, the Village of Channahon is a home rule municipal corporation.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHANNAHON WILL AND GRUNDY COUNTIES, ILLINOIS IN THE EXERCISE OF ITS HOME RULE AND OTHER POWERS AS FOLLOWS:

**Section 1. Code Amendment.**

That 97.01 and 97.04(B) of the Channahon Code of Ordinances be and the same are hereby amended to include "or 6-303" after the phrase "11-501".

**Section 2. Severability.**

If any section, paragraph, clause or provision of this Ordinance is held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this Ordinance.

**Section 3. Repealer.**

All ordinances, resolutions, orders or parts thereof, which conflict with the provisions of this Ordinance, is to the extent of such conflict, hereby repealed.

**Section 4. Effective Date.**

This Ordinance shall be in full force and effect after its passage, approval, and publication in pamphlet form.
