### **Constructing Principal Structures Over Property Lines**

Mr. McMahon reported that Trustee Jerry Papesh requested that he prepare an ordinance to amend the Village Development Code to allow principal structures to be constructed over lot lines if the lots are in single ownership.

After a description of the request by Mr. McMahon, Chairperson Ciarlette stated the code requires a building has to be within the property lines and setbacks. So, he is asking to put something in the code that allows someone to build on the property line?

Commissioner McCollom stated it sounds like he wants two adjacent lots owned by the same owner should not have to create a new subdivision to combine lots. He then stated his thoughts on the pros and cons of creating a one new subdivision from two lots and he is not in favor of allowing construction over lot lines and would rather have new subdivision created to combine two lots.

After a brief discussion, the Commission was generally not in favor of the request.

Chairperson Ciarlette asked for a motion to adjourn.

Commissioner Proffitt made a motion to adjourn the meeting at 6:25 p.m. Seconded by Commissioner Host. All were in favor.
